REITERATION OF POLICY AND OPERATIONAL GUIDELINES FOR PROVISION OF SPARE PARTS REQUIRED TO MAKE THE OUT OF ORDER/OUT OF WARRANTY BIO-MEDICAL EQUIPMENT FUNCTIONAL:

Please refer to this office letter No. PSHD-BERC/Poli-SP/2020, dated 01-02-2021:

2. It is to reiterate that provision of spare parts identified by the BERC engineers is the responsibility of the concerned health facility. The said instructions were clearly mentioned in the Policy Manual of BERC notified vide No. BERC-55-1/2018 version: VI, dated 1st November, 2018 and Policies & Operational guidelines issued with approval of the competent authority vide letter No. PSHD-BERC/Poli-SP/2020 dated 01-02-2021(COPY ENCLOSED). It is further added that health facilities of P&SHD have head of Account A13101-R&M of Machinery and Equipment with provision of funds. It is however observed with concern that 1154 number of complaints are pending due to non-provision of spares despite identified by the BERC Technical Teams.
3. In view of forgoing, It is once again requested to arrange the spare parts identified by the BERC at the earliest and inform BERC on Helpline 1454, so that pending complaints may be resolved at the earliest in public interest.
